In consideration for being allowed to use the Community Garden, I, on behalf of myself and my spouse, children, heirs, beneficiaries, executors, etc., hereby (1) release, and forever discharge Orangewood Friendship Garden and Orangewood Presbyterian Church, each of their officers, agents, members, employees, representatives, the Garden Manager, the Garden Committee and all others employed by or working for any of those persons of and from any and all liability, claims, demands, actions and causes of action whether known or unknown whatsoever, arising out of or related to any loss, damage, or injury to me that may or does occur during any my presence on the grounds of Orangewood Presbyterian Church or in the Community Garden; (2) waive any and all liability, claims, demands, actions and causes of action whether known or unknown whatsoever, against the Orangewood Friendship Garden and Orangewood Presbyterian Church, each of their officers, agents, members, employees, representatives, the Garden Manager, the Garden Committee and all others employed by or working for any of those persons, arising out of or related to any loss, damage, or injury to the undersigned that may or shall occur during my or any of my guests' presence on the grounds of Orangewood Presbyterian Church or in the Community Garden; and (3) indemnify Orangewood Friendship Garden and Orangewood Presbyterian Church, each of their officers, agents, members, employees, representatives, the Garden Manager, the Garden Committee and all others employed by or working for any of those persons and hold them harmless of and from any and all liabilities, obligations, claims and damages, whether direct, indirect or consequential, including, but not limited to, reasonable attorneys' fees and expenses of litigation, arising from or related to my or any of my guests' presence on the grounds of Orangewood Presbyterian Church or in the Community Garden.
